Boarding Agreement

This is a contract between **Palmetto Pet Resort & Pet Spa** and the pet owner. **Palmetto Pet Resort & Pet Spa** agrees to exercise due and reasonable care and to keep the **Palmetto Pet Resort & Pet Spa** premises sanitary and properly enclosed. The pets are to be fed properly and regularly and to be housed in clean, safe quarters. All pets are boarded or are otherwise handled or cared for by **Palmetto Pet Resort & Pet Spa** staff without liability on **Palmetto Pet Resort & Pet Spa** 's part for loss of damage from disease, theft, fire, death, escape, injury or harm to persons, other pets or property by said pets, for other unavoidable causes, due diligence and care having been exercised. ___ **initial**

If the pets become ill or if the state of the animals health otherwise requires professional attention **Palmetto Pet Resort & Pet Spa** , in its sole discretion, may engage the services of a veterinarian of its choosing, or administer medicine, or give other requisite attention to the pet, and expenses thereof shall be paid by owner. ___ **initial.**

If the pet enters the kennel with fleas **Palmetto Pet Resort & Pet Spa** in its sole discretion may treat the pet for fleas using either **Capstar** and/or **Frontline** and the expenses there of shall be paid by the owner. If the owner has issue with either product, a specified product will be suggested by the owner at check-in. This product will be used during all subsequent boarding visits at the discretion of **Palmetto Pet Resort and Pet Spa** and the expenses there of shall be paid by the owner. ___ **initial.**

Daily boarding charge begins at the date entered below. Owner agrees to notify **Palmetto Pet Resort & Pet Spa** in advance if there is any change in the date this boarding animal is to be picked up. Owner understands and agrees that pets picked up by Owner after 12:00PM shall be charged for a full days stay. Clients will pay full cost, and any additional charges incurred by Owner, for the scheduled boarding upon pick-up. Owner further agrees that pets shall not leave **Palmetto Pet Resort & Pet Spa** until all charges are paid to **Palmetto Pet Resort & Pet Spa** by Owner. **Palmetto Pet Resort & Pet Spa** shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from boarding pets at **Palmetto Pet Resort & Pet Spa**.

Any animal left uncalled for, or unpaid for, shall be placed in foster care seven days from the scheduled date of pickup (as noted herein). Owner shall be liable for complete boarding bill as well as all other charges incurred in the care, maintenance, and foster care of said animal as listed above _____ Initial.

The Owner of the animal or his agent agrees to pay for reasonable attorney's fees incurred by Palmetto Pet Resort & Pet Spa in the collection of any outstanding fees or other charges incurred by the Owner of the animal. _____ **Initial.**
